#### a. ROLL CALL

Present were Councilors John Caruso, Chris Grotton, and Maurice Day. Frank Roma and Chris Cookson were absent.

#### b. CITIZEN INPUT - OPPORTUNITY FOR

No one in the audience choose to address the Council.

c. [24-07-01] Council discussion, to see what action the Town Council will take regarding amending the GA Ordinance.

Mr. Caruso motioned to accept the GA Ordinance; Mr. Day seconded. The motion passed unanimously.

d. [24-07-02] Council discussion, to see what action the Town Council will take regarding accepting a new Recreation Committee Member Application.

Recreation Director Carey Besse introduced Adam Metivier to the Council. Mr. Caruso made a motion to accept Mr. Metivier as a member of the Rec Committee. Mr. Day seconded the motion. The motion passed unanimously.

e. [24-07-03] Council discussion, to see what action the Town Council will take regarding the use of the portable building.

Mr. McClung informed the Council that the potentially intended uses for the portable building are not working out. Mr. McClung recommends we put the building out for bid. Mr. Day made a motion to put the building out to bid, Mr. Caruso seconded. The motion passed unanimously.

Mr. Caruso made a motion to table this item until the next meeting, the motion was seconded by Mr. Day. The motion to table passed unanimously.

g. [24-07-05] Council discussion, to see what action the Town Council will take regarding signing the warrant articles provided by UTC for the November 5<sup>th</sup> election.

Mr. Caruso made a motion to accept, Mr. Day seconded. The motion passed unanimously.

Mr. Caruso motion to accept, Mr. Day seconded. Motion passed unanimously.

i.[24-07-07] Minutes of September 12<sup>th</sup>, 2024, Regular Council Meeting APPROVAL OF,  
Mr. Day motioned to accept; Mr. Caruso seconded. Motion passed unanimously.

#### Manager/Council Items/Other Business

Mr. McClung informed the Council we are not able to accept any more construction debris at the Landfill for the remainder of the season.

He informed Council of the paving projects on Phillips Rd. and Lakeview Rd. As well as curb work done at Checkout Convenience store.
